Only approved services can be funded by Support at Home and in accordance with your assessed needs, support plan and help plan.

## Support At Home – FAQs

### Will I lose any of my current funding or unspent funds I held with my Home Care Package?

If you held a Home Care Package on or before 30th June 2025, your current funding level income and any unspent funds be included as available funds under Support at Home.

### Will I have to contribute to the cost of my services?

If you are a full pensioner and assessed for or already had a Home Care Package prior to 12th September 2024, you will not be required to contribute to your approved services under Support at Home.

If you were assessed after 12th September 2024 and are a full pensioner, then you will be required to contribute a percentage of the fees listed under each service category.

### Do I still need to pay an Income Tested Fee?

You will no longer pay a daily Income Tested Fee. You will transition to paying a contribution for services that are delivered to you. You will be informed of your discounted contribution rate.

### What if I need a service not approved under by Support at Home support plan?

Please contact your Iris Aged Care, Care Partner, to arrange any services you'd like to pay for privately. Your Care Partner can assist you to being reassess for a higher Support at Home Classification and new Support Plan.
